

ENACT – why?

The background and impact

ENACT impact fits within the Europe2020 strategy and in particular with the achievement of the targets for "Climate change and energy sustainability". ENACT will have a high strategic impact at national / European level:

- 1) Improved management of buildings and increased their energy efficiency,
- 2) Increased innovation related to specific technologies and techniques for energy efficiency,
- 3) Increased training (quantitative and qualitative) on energy efficiency issues new, well defined and structured courses to train the new figure of energy auditor according to the national / regional standards.



"Member States shall ensure that the energy performance certification of buildings and the inspection of heating systems and air-conditioning systems are carried out in an independent manner by qualified and/or accredited experts, whether operating in a self-employed capacity or employed by public bodies or private enterprises.

Experts shall be accredited taking into account their competence.

Member States shall make available to the public information on training and accreditations. Member States shall ensure that either regularly updated lists of qualified and/or accredited experts or regularly updated lists of accredited companies which offer the services of such experts are made available to the public."

ENACT – what?

The activities

The activities within the 24-month project period in the participating countries (Italy, Portugal, Poland and Spain) are:

Analysis of the existing training / qualification frame of energy auditors — overview of the national / regional legislation for the transposition of the European Directive on energy performance buildings, the professional qualification system, the relative compulsory (formal) training and the informal and non

formal training;

Comparative analysis of the national frames and preparation of the inter-country matrix to define the common issues as well as the best practices of the "Energy **Auditors Competencies and Professional Profiles"**;

- Definition of the learning outcomes and program for the training of the energy auditors and of the relative ECVET (European Credit system for vocational education and training) and the relative learning resources and material;
- European and National validation of the professional figure of energy auditor as trained and qualified through the above-defined training and qualification process;
- Design and creation of an ICT system, modules and tools to implement the above-defined training and qualification process and its overall validation;
